**NOTICE OF SETTLEMENT HEARING**

Enforcement Staff will bring an application to a Hearing Panel of the Canadian Investment Regulatory Organization (“CIRO”)<sup>1</sup> requesting that it accept a settlement agreement between Enforcement Staff and George Alexander Abisaleh pursuant to Rules 14 and 15 of the Mutual Fund Dealer Rules of Procedure and Mutual Fund Dealer Rule 7.4.4.

**THE SETTLEMENT AGREEMENT**

The settlement agreement addresses proposed allegations that George Alexander Abisaleh contravened Mutual Fund Dealer Rules 2.1.1 and 2.1.4 by misappropriating or otherwise obtaining monies from clients, some or all of which the Respondent did not repay or account for.

**THE SETTLEMENT HEARING**

The settlement hearing will be held by videoconference on Monday, June 29, 2026 at 10:00 a.m. ET

The settlement hearing will be held at: Toronto, ON.

The hearing is not open to the public, but the public will be notified if the settlement agreement is accepted. If the settlement agreement is accepted, it will be made public together with the Hearing Panel’s reasons.
